## AMENDMENT TO DECLARATION SUBMITTING STAGE I OF SEAVIEW CONDOMINIUM TO THE OREGON CONDOMINIUM ACT

This Amendment to Declaration ("Amendment") is made and executed by SEAVIEW ASSOCIATES, an Oregon limited partnership (hereinafter called "Declarant").

Declarant has created a condominium known as Seaview Condominiums, which is located in Tiliamook County, Oregon ("Project"). As part of the creation of the Project, the Declarant recorded the Declaration in Book 379, at Page 703, Tiliamook County Records. The purpose of this Amendment to the Declaration is to permit unit owners of the Project to sell fractional interests in such units pursuant to the terms of a Declaration of Fractional Interest Agreement") of even date herewith.

NOW, THEREFORE, Declarant does hereby declare and provide as follows:

- Section 1 of the Declaration is amended by inserting Section 1.8 to read as follows:
  - 1.8 "Fractional Interests." Unit owners of the Project shall have the right to sell not more than ten (10) fractional interests in their condominium unit pursuant to the terms of Fractional Interest Agreements to be provided by the Developer and signed by owners of fractional interests in units.
  - 2. Section 11 of the Declaration shall be amended to read as follows:
    - 11. <u>YOTING RIGHTS</u>. The owners or coowners of each unit, or owners holding fractional interests in units, shall be entitled to a total of one (1) vote per unit, at is more particularly described in the By-Laws.
  - Section 17 of the Declaration shall be amended as follows:
    - 17. CONFLICTING PROVISIONS. In the event of a conflict between or among the Declaration, By-Laws, Fractional Interest Agreement, and any administrative rules and regulations, the provisions of the Declaration, as amended, chall be paramount to the By-Laws,
