2002 AMENDMENT TO BYLAWS OF THE ASSOCIATION OF UNIT OWNERS OF SEAVIEW CONDOMINIUMS

This 2002 Amendment to Bylaws of the Association of Unit Owners of Seaview Condominiums is made by the Association of Unit Owners of Seaview Condominiums, an Oregon nonprofit corporation (the "Association").

RECITALS

- A. Seaview Condominiums (the "Condominium") is a condominium, located in Tillamook County, Oregon. The Condominium was created and is governed by the following documents, in the records of Tillamook County, Oregon:
 - 1. Declaration Submitting Stage I of Seaview Condominiums to the Oregon Condominium Act, recorded in Book 379, Page 703, as amended and supplemented ("Declaration").
 - 2. Bylaws of the Association of Unit Owners of Seaview Condominiums, recorded in Book 379, Page 704, as amended ("Bylaws").
 - 3. Plat of Seaview Condominiums Stage I, County of Tillamook, State of Oregon.
- B. The Association is the Association of Unit Owners of Seaview Condominiums, an Oregon nonprofit corporation, formed pursuant to the Declaration, Bylaws and Articles of Incorporation filed May 9, 2000 in the office of the Oregon Secretary of State, Corporation Division.
- C. Under ORS 100.410 and Article XIII, Section (1) of the Bylaws, the Association and the owners may adopt amendments to the Bylaws.
